法学专业（非师范）培养方案

The Program of Law(Non-Teacher Education)

一、专业简介

I. Overview of the Program

法学专业始于 1938 年建立的西南联合大学法商学院法律学系，20 世纪 70 年代末，我院在思想政治教育专业开设“法学概论”课程，1998 年，在学院“思想政治教育”本科专业下设法律方向。2001 年，法学本科专业获得教育部批准设立，2002 年，招收首届法学专业本科生，至今，已有 10 余届共计 1500 余名全日制本科毕业生。2012 年，教育部批准自主设置二级学科“教育法学”硕士学位授权点，2013 年，中共云南省纪律检查委员会和云南师范大学合作共建云南纪检监察学院，在国内高校首创法学专业（纪检监察方向），2014 年，教育部批准设立法律硕士授权点，形成了法学本科教育和研究生教育相衔接的办学格局。法学专业教育立足边疆、服务云南、面向全国，成为特色鲜明、国内有影响、省内领先的法治人才培养基地。

The law major of Yunnan Normal University dated back to Law Department , School of Law and Business in Southwest Associated University established in 1938. In the late 1970s, the course of "Introduction to Law" was offered successively in the undergraduate major of ideological and political education in our School and in 1998 the Legal Program was set up in the major in our School. In 2001, the law major of the undergraduate was established with the approval of the Ministry of Education of P.R.China . In 2002, the first freshmen of the law major were enrolled by our school and there have been more than 10 full-time undergraduate classes up to now while more than 1500 students have been awarded a bachelor's degree in law. In 2012, the Ministry of Education approved the authorization program for the Master Degree of Education Law. In 2013, School of Disciplinary Inspection and Supervision was jointly established by Yunnan Provincial Disciplinary Inspection Commission of the Communist Party of China and Yunnan Normal University ,in which the law major (discipline inspection and supervision) was

regarded as the first one in the universities and colleges in the domestic so far .In 2014, the Ministry of Education approved the establishment of the authorization program for the Degree of Juris Master. So far our School has formed a cohesive pattern of the law undergraduate education and the law postgraduate education. The training goal of the Law education is clear, the training requirement is strict, and the curriculum is set up scientifically, which is based on the southern Frontier, serves Yunnan, and goes towards the whole country, so that our school has become a training center for the rule of law with distinctive characteristics ,with domestic influence and leading in Yunnan Province.

二、培养目标

II Objectives

本专业人才培养坚持立德树人、德法兼修，适应建设中国特色社会主义法治体系，建设社会主义法治国家的实际需要。培养德才兼备，具有扎实的专业理论基础和熟练的职业技能、合理的知识结构，具备依法执政、科学立法、依法行政、公正司法、高效高质量法律服务能力与创新创业能力，熟悉和坚持中国特色社会主义法治体系的复合型法治人才及后备力量。本专业学生经过 4 年的培养，应当实现以下目标：

目标 1: 热爱社会主义祖国，拥护中国共产党的领导，掌握中国特色社会主义理论体系，有正确的世界观、人生观、价值观。

目标 2: 能适应现代法治社会发展，系统掌握法学基本理论和方法，熟悉国内国际法律规则，了解学科发展前沿，形成完整的法律专业知识体系；

目标 3: 具备将所学的专业理论与知识融会贯通，灵活地从事法律实务的基本技能，具备良好的法律思维、法律表达和法律应用等综合能力。

目标 4: 具有合格公民的基本素质和道德素养，具备健全的职业人格、强烈的法律职业认同感，具有服务于建设社会主义法治国家的责任感和使命感。

目标 5: 具备健康的身心 and 良好的人文素养，能够了解部分人文社会科学和自然科学等非法学专业基础知识，能对多学科知识的进行交叉运用，形成更多元的分析解决问题能力。

In order to meet the practical needs of building a socialist country ruled by law, the cultivation of talents of this specialty insists on establishing morality and cultivating both morality and law, and adapts to the construction of socialist rule of law system with Chinese characteristics, in order to develop both moral and talented, have a solid professional theoretical basis and skilled professional skills, reasonable knowledge structure, have the ability to govern according to law, scientific legislation, administration according to law, fair justice, efficient and

high-quality legal services and innovative entrepreneurial capabilities, to be familiar with and adhere to the rule of law system of socialism with Chinese characteristics and the compound rule of law talents and reserve force. After four years of training, the students of this major should achieve the following goals:

Objective 1. To love the socialist motherland, support the leadership of the Communist Party of China, understand the theoretical system of socialism with Chinese characteristics, have correct outlook on the world, outlook on life and values.

Objective 2. To adapt to the development of modern legal society, master the basic theories and methods of law systematically, be familiar with domestic and international legal rules, understand the frontier of discipline development, and form a complete legal professional knowledge system.

Objective 3. To have the basic skills of integrating professional theory and knowledge, flexible in legal practice, and have good comprehensive ability in legal thinking, legal expression and legal application.

Objective 4. To have the basic qualities and moral qualities of qualified citizens, a sound professional personality, a strong sense of legal professional identity, and a sense of responsibility and mission to serve the construction of a socialist country ruled by law.

Objective 5. To have a healthy body and mind and good humanistic literacy, be capable of understanding some of the basic knowledge of humanities, social sciences, natural sciences and other non-law majors, have ability to carry out cross-use multi-disciplinary knowledge, and form a more pluralistic analysis and problem-solving ability.

三、毕业要求

III graduation requirement;

本专业学生经过 4 年专业培养，应达到如下要求：

1.法学知识：能够掌握各综合及部门法学学科的基本知识点，并能综合各学科知识形成完整的知识结构。

2.研究能力：有初步的法学问题研究能力，能发现并初步研究法学发展中存在的问题。

3.综合运用能力：能够理论联系实际，具备综合运用各类法学知识，分析、解决法律问题的初步能力，具有适应法治建设的自主学习能力和创新意识。

4.职业道德：具有合格公民的基本素质和道德素养，具备健全的职业人格、强烈的法律职业认同感，具有服务于建设社会主义法治国家的责任感和使命感。

5.法律专业技能：形成严谨的法学思维方式，有良好的法律实务技能，能撰写法律文书和法学论文，能进行良好的表达、沟通和合作。

6.使用现代工具：能够熟练使用计算机，熟悉各类专业的数据库和软件，并运用其进行知识学习和理论研究。

7.语言能力：较好的外语知识与应用能力，有熟练掌握一门外国语，具有较好的听、说、读、写能力，能够较为顺利地阅读外文资料，具有国际视野。

8.终身学习：具有自主学习和终身学习的意识，有不断学习和适应发展的能力，能够通

过自主学习适应经济社会发展的需要。

After four years of professional training, the students in the major should meet the following requirements:

1. Legal knowledge: To have the ability to master the basic knowledge points of each comprehensive and departmental law discipline, and synthesize the knowledge of each discipline to form a complete knowledge structure.

2. Research ability: To have the preliminary legal problem research ability, be able to discover and preliminarily study the existing problem in law development.

3. Comprehensive utilization ability: to have the ability to integrate theory with practice, have comprehensive use of all kinds of legal knowledge, analysis and solution of legal problems, with the ability to adapt to the rule of law construction of self-learning ability and innovative consciousness.

4. Professional ethic: to cultivate basic qualities and moral qualities of qualified citizens, with a sound professional personality, a strong sense of legal professional identity, and a sense of responsibility and mission to serve the construction of a socialist country ruled by law.

5. Legal professional skills: To form a rigorous legal thinking mode, have good legal practical skills, be able to write legal documents and legal papers, be capable of expressing, communicating and cooperating well.

6. Use of modern tools: To be proficient in computer, familiar with all kinds of professional databases and software, and use it for knowledge learning and theoretical research.

7. Language ability: To have good foreign language knowledge and application, good command of a foreign language, good listening, speaking, reading and writing skills, be capable of reading foreign language materials more smoothly, and with an international vision.

8. Lifelong learning. To have the consciousness of self-study and lifelong learning, have the ability of continuous learning and adapt to development, and have the ability to adapt to the needs of economic and social development by means of autonomous learning.

VII. Main Experiments (Practices) and Teaching Requirements

1. 主要实验（践）：

1.Main Experiments (Practices)

法学专业通过专业实践课程（见习、实习、社会调查、毕业论文）、理论课程附设实践环节和第一至第六学期专业技能训练活动三个板块的实践教学设计，适应法学专业发展和社会发展的需要。实践教学设计对接法学专业人才的职业能力发展需求，内容丰富，教学体系

完整、目标明确、前后衔接、阶梯递进，实践教学与理论教学有机结合、相互促进，贯穿培养全程。

By the professional practice curriculum (probation, practice, social investigation, graduation thesis), the practical teaching design of theory course with practical links and professional skills training activities in the first to sixth semester, the speciality of law meets the needs of the development of the specialty of law and the development of the society. The practical teaching design meets the needs of the professional ability development of the law professionals, the content is rich, the teaching system is complete, the goal is clear, with the front-and-back connection, the step-by-step progress, and the combination with the practice teaching and the theory teaching organically so as to promote each other and go through the whole process of training.

2. 实验（践）教学要求：

2. Teaching Requirements

根据实践环节的不同形式，实践教学的考核与要求也各不相同。

（1）修完本专业计划规定的所有实践课程，获得相应的学分。实践课程总计 26 周课时，13 学分。其中，结合法学专业理论知识的学习，专业见习（1）和专业见习（2）分别安排在第四学期和第五学期，各 2 周、1 学分；专业实习和社会实践统一进行，安排在第七学期，专业实习总计 10 周、6 学分，社会实践总计 2 周、1 学分。毕业论文安排在第八学期，总计 10 周、4 学分。

（2）修完本专业计划规定的所有理论课程附设实践环节，获得相应的学分。法学专业理论课程民法附设 1 个实践教学学分，总计 1 学分。

（3）参与第一至第六学期专业技能训练活动，达致训练目标。法学专业设置职业规划、假期实践观摩、案例研修、法律文书写作、法学课题研究、学科竞赛等，丰富实践教学，提升学生的综合素质和实际运用能力。

In accordance with the different forms of practice, the assessment and requirements of practice teaching are different.

（1）It can receive corresponding credits after completing all practical courses specified in this professional plan. The practical course has a total of 26 weeks of class hours, with a total of 13 credits, in which, combined with the study of theoretical knowledge of the law major, the professional internship (1) and the professional internship (2) are arranged in the fourth semester and the fifth semester respectively, 2 weeks each, and 1 credit. The professional internship and social practice are unified, which is arranged in the seventh semester, there is a total of 10 weeks of professional practice, 6 credits, 2 weeks of social practice, and 1 credit. The graduation thesis is scheduled for the eighth semester with a total of 10 weeks and 4 credits.

（2）It can receive corresponding credits after completing all practical courses specified in this professional plan. The theoretical courses of law specialty include civil law, with one practical teaching credit with a total of 1 credits.

（3）To take participation in professional skills training activities in the first to sixth semesters to achieve training objectives. Law majors set up professional planning, holiday

practice observation, case study, legal writing, research of law subject, subject competition, etc., so as to enrich practical teaching, improve students' comprehensive quality and practical application ability.
